



Assistant State Attorney Pamela Gale Davis

Pamela left her earthly home on February 5, 2023. She was born in Hollywood, Florida on February 11, 1960, to the late John Davis and Sylvia Davis.

Pamela attended Hollywood Hills High School. She went on to graduate from Florida State University for Undergraduate and Law School. Upon graduation, Pamela was certified as a Reserve Police Officer with the Dania Police Department.

Pamela found her passion when she began her career as a prosecutor in the Ninth Judicial Circuit's State Attorney's Office on August 1, 1991, where she successfully litigated many sex crimes, domestic violence, human trafficking, and homicide trials. Pamela was the first Human Trafficking prosecutor in the Circuit, the first Black female Sex Crimes and Homicide prosecutor in the Circuit, as well as one of the first few Black supervisors in the office.

With more than 30 years of service as an Assistant State Attorney, Pamela served her community and its citizens well. Her grieving family, extended work family, and many friends and loved ones are missing her kind and gentle spirit, as well as her bright, infectious smile.

Pamela was a loving mother, sister, cousin, and friend to all who had the

pleasure of being in her presence. She was preceded in death by her parents, as well as her sister-in-law, Patricia Jordan.

Pamela leaves to mourn: her son (Brandon Davis), her brother (Daryl Davis), numerous aunts, uncles, cousins, and a host of other close relatives, friends, coworkers, church family and neighbors who will miss her every day.

Pamela will be remembered for her mentorship, as well as for her zealous advocacy of victims. Her legacy will live on in all of us who were so fortunate to have gotten the opportunity to learn from, work with, and love the woman who inspired us to act justly, love mercy, and walk humbly.
